

## **COPYRIGHT LICENSE, WAIVER OF MORAL RIGHTS, AND INDEMNITY**

**For the Photographs and videos uploaded on Collector/Crowdriff for Ontario's Highlands Tourism Organization (OHTO).**

**WHEREAS** are the copyright holder of the photographs/videos you post;

**And you agree as follows:**

1. to grant the Ontario's Highlands Tourism Organization OHTO a perpetual, worldwide, non-exclusive, irrevocable, transferable, sub-licensable, royalty-free, fully paid up right and license: (a) to publish, use, display, modify, reproduce and distribute, in any form, the photograph-videos your username, your image, your likeness and other personal information as may be contained therein (the "Content"); and (b) to authorize other persons, agents, contractors or sub-contractors, to do any of the former on behalf of the OHTO or a Client, for the remainder of the unexpired term of the copyright. The undersigned acknowledges that they are not entitled to, and shall not seek, any compensation fees or royalties of any kind arising in any way from this license, irrespective of whether the Content is used or not. The undersigned hereby waives any right to inspect or approve the use of the Content.
2. The undersigned expressly, irrevocably and without restriction, hereby waives in favour of the OHTO and all sublicensees and assignees all his/her Moral Rights with respect to the Content. In this waiver of Moral Rights, "Moral Rights" has the same meaning as in the *Copyright Act*, R.S.C. 1985, c. C-42, as amended or replaced from time to time and includes comparable rights in applicable jurisdictions.
3. The undersigned at this moment releases and forever discharges the OHTO and its employees, representatives and affiliates from any claims, obligations or liability of every kind arising in any way out of the use of the Content by any person, including any third party.
4. The undersigned warrants that the Content is wholly original to the undersigned, and that he/she is the original photographer-videographer. The undersigned warrants that the Content was not scripted, professionally produced, contracted, directed or paid for.
5. The undersigned warrants that he/she has the right to grant to the OHTO all of the rights granted or provided to be so granted in this agreement. The undersigned warrants that the Content (and each individual component thereof) will not give rise to any claims whatsoever, including, without limitation, claims of infringement, invasion of privacy or publicity, or infringe on any rights and/or interest of any third party.
6. The undersigned agrees that the Content does not contain images of identifiable third party individuals or that if it does, the parties have given permission and consent to use the electronic media images for any legal use by OHTO and their affiliates.
7. The undersigned warrants that the Content does not violate any law, statute or regulation. The undersigned further warrants that the Content is not defamatory, trade libelous, pornographic or obscene, and does not contain, depict, include, discuss or involve, without limitation, any of the following: dangerous or unsafe behaviour or depictions; alcohol/drug consumption or smoking; crude/vulgar or offensive language and/or symbols; derogatory characterizations of any ethnic, racial, sexual, religious or other groups; content that endorses, condones and/or discusses any illegal, inappropriate or risky behaviour or conduct; personal information of third party individuals; telephone numbers and/or addresses (physical or electronic); commercial messages; comparisons or solicitations for products or services; any identifiable third party products, trade-marks, brands and/or logos; and/or any other content that is or could be considered inappropriate, disparaging, unsuitable or offensive, as determined by OHTO in its sole and absolute discretion.
